Urner Barry regularly solicits feedback from stakeholders to ensure that our coverage reflects current trading conditions and practices. To improve market transparency and to provide stakeholders meaningful information, Urner Barry is requesting feedback on the following proposed changes to its Mexican beef reporting methodologies:

1. The addition of a weekly quotation to reflect market and transactional data for Mexican-produced 80% boneless beef FOB Laredo USA. This quote would be released on the Monday closing market report and include data from the week prior.
